1. Introduction

a. General information

Air Quality Portal Kosovo <u>https://airqualitykosova.rks-gov.net/</u> is a service for the public providing air quality information from the monitoring stations and from 3-day forecast: today, tomorrow and next day. Information is visualized on maps and included in reports.

Data from monitoring stations contains validated data for six pollutants: PM10, PM2.5, NO_2 (nitrogen dioxide), O_3 (ozone), SO_2 (sulphur dioxide) and CO (carbon monoxide).

Forecast is prepared for four major pollutants (NO₂, PM10, PM2.5 and O₃) using modeling forecast system. Results are based on the European Air Quality Index (AQI) methodology, with pollution bands from Good through to Extremely Poor. The Portal provides maps of NO₂, PM10, PM2.5 and O₃ concentrations and Air Quality Index level map, which is the highest of the AQI levels separately for four pollutants at every location. The default map view covers all Kosovo municipalities, but the user can zoom in to view the air pollution forecast for an individual location. Separate map with much higher resolution is prepared for Prishtina. The background maps are based on the free OpenStreetMap.

Air quality forecast for Kosovo is calculated every day for the next 3 days. Finally forecast includes forecast data for current day and two next days. Every hour assimilation of measurement data in modelling process is carried out to increase accuracy of the forecast. For NO₂ and ozone 1 hour concentrations are displayed on the maps. For PM10 and PM2.5, based on one-hour concentrations, running 24-hour average values are calculated. The forecast of air pollutants, in addition to the meteorology forecast, is also based on the emission load forecast.

b. What is air pollution?

Clean air is a mixture of nitrogen (78%), oxygen (21%), carbon dioxide (CO2), argon, water vapor and other inert gases. Air pollution refers to release of substances in the atmosphere that are harmful to humans, living organisms or plants, and cause damage to climate, materials and buildings. Air pollution consists of chemicals or particles: gases, solid particles, or liquid droplets. Primary air pollution is emitted from domestic or municipal heating systems, factories, cars, large combustion sources like power plants, agriculture or natural sources like volcanoes. Air pollution is most common in large cities where emissions from many different sources are cumulated.

Air pollution often appears as a cloud making the air murky. It is called smog. The word "smog" comes from combining the words "smoke" and "fog."

c. Air quality limits

The EU's air quality directives (2008/50/EC Directive on Ambient Air Quality and Cleaner Air for Europe and 2004/107/EC Directive on heavy metals and polycyclic aromatic hydrocarbons in ambient air) set pollutant concentrations thresholds that shall not be exceeded in a given period of time. Selected EU standards and the World Health Organization (WHO) guidelines are summarized in the

table below. These apply over differing periods of time because the observed health impacts associated with the various pollutants occur over different exposure times.

The WHO guideline values are set for the protection of health and are generally stricter than the comparable politically agreed EU standards.

d. Forecast of air quality

Air quality forecasts are based on weather forecasts, Copernicus Atmosphere Monitoring Service (CAMS) and run of the regional model CALPUFF. Additional information comes from national air quality monitoring system – set of 13 monitoring stations.

The data on pollution sources in Kosovo are based on annual average emissions and do not include day-to-day variations in the emissions.

The concentrations of four pollutants are calculated: nitrogen dioxide (NO₂), particulates (PM10 and PM2.5) and ozone (O₃). From the concentrations the daily Air Quality Index (AQI) of each pollutant is derived. The AQI corresponding to the pollutant which gives the highest value of the AQI is the value presented, so the AQI shown may correspond to a different pollutant (NO₂, PM10, PM2.5 or O₃) on different days.

The operational model configuration was run with hourly observed meteorological data and hourly background concentrations of PM10 and PM2.5, taken from the CAMS Ensemble Reanalysis dataset, which combines regional-scale modelled data, in situ observations and satellite observations to give a 'best guess' picture of pollution levels at 0.1 degree resolution across Europe.

e. European Air Quality Index¹

The European Air Quality Index allows users to understand more about air quality where they live, work or travel. Displaying up-to-date information for Kosovo, users can gain insights into the air quality in regions and cities.

The Index is based on concentration values for up to five key pollutants, including:

- particulate matter (PM10),
- fine particulate matter (PM2.5),
- ozone (O₃),
- nitrogen dioxide (NO₂),
- sulphur dioxide (SO₂).

It reflects the potential impact of air quality on health, driven by the pollutant for which concentrations are poorest due to associated health impacts.

These data are not formally verified.

By default, the air quality index depicts the situation of the last full hour. Users can then select any hour in the preceding 24 hours.

European Union legislation sets air quality standards for both short-term (hourly or daily) and long-term (annual) air quality levels. Standards for long-term levels are stricter than for short-term levels since serious health effects may occur from long-term exposure to pollutants.

The Index indicates the short-term air quality situation. It does not reflect the long-term (annual) air quality situation, which may differ significantly.

The air quality index is not a tool for checking compliance with air quality standards and should not be used for this purpose.

Methodology

The Index uses 'up-to-date' air quality data from Kosovo monitoring station and from forecast modelling using Calpuff and CAMS models.

Concentrations values for up to five key pollutants (PM10, PM2.5, SO₂, NO₂ and ozone) determine the index level that reflects air quality at each monitoring station. The index corresponds to the highest level for any of five pollutants, according to the table shown below. For the forecast, 4 pollutants are used: ozone, nitrogen dioxide, and particulate matter (PM10 and PM2.5).

Icons on the map represent the locations of air quality monitoring stations. The colors reflect air quality at the given hour at that station.

Averaging time for pollutants

For NO₂, O_3 and SO₂, hourly concentrations are fed into the calculation of the index.

For PM_{10} and $PM_{2.5}$, the 24-hour running means for the past 24 hours are fed into the calculation of the index.

Bands of concentrations and index levels

The bands are based on the relative risks associated to short-term exposure to $PM_{2.5}$, O_3 and NO_2 , as defined by the World Health Organization in its report on the Health Risks of Air Pollution in Europe project (HRAPIE project report).

The relative risk of exposure to $PM_{2.5}$ is taken as basis for driving the index, specifically the increase in the risk of mortality per 10 μ g/m³ increase in the daily mean concentration of $PM_{2.5}$.

Assuming linearity across the relative risk functions for O_3 and NO_2 , we calculate the concentrations of these pollutants that pose an equivalent relative risk to a 10 μ g/m³ increase in the daily mean of PM_{2.5}.

For PM_{10} concentrations, a constant ratio between PM_{10} and $PM_{2.5}$ of 1:2 is assumed, in line with the World Health Organization's air quality guidelines for Europe.

For SO₂, the bands reflect the limit values set under the EU Air Quality Directive.

Air quality measurements that exceed the maximum values in the 'extremely poor' category are not taken into account for the index calculation, since these values are typically found to be erroneous.

f. Health recommendations

Which groups of people are more sensitive to air pollution?

• People with lung disease (COPD, asthma, lung cancer), heart disease (such as angina, and a history of heart attacks) or diabetes are more sensitive to air pollution.

• Seniors are at higher risk because of weakening of the heart and lungs and an increased likelihood of health problems such as heart and lung disease.

• **Children** are also more vulnerable to air pollution because they have a less-developed respiratory system. Because of their size, children inhale more air per kilogram of body weight than adults.

• **Pregnant women** - Exposure to air pollution during pregnancy can increase the risk of premature birth and low birthweight. Premature birth is birth that happens too soon, before 37 weeks of pregnancy.

Please follow the 3 steps below to use the Air Quality Index:

Step 1: Determine whether you (or your children) are likely to be at-risk from air pollution. For more information on people who may be affected by air pollution on a short-term basis visit <u>niph-rks.org</u>. Your doctor may also be able to give you advice.

Step 2: Check the air pollution forecast.

Step 3: Use the health messages below corresponding to the highest forecast level of pollution as a guide.

- ² Masks or particulate respirators may help in special circumstances if you have to be outside whilst pollution levels are high although scientific evidence is limited on their effectiveness against air pollution. Masks need to be of a special type and require special fitting. Masks should be disposable, regularly changed and have a rating of at least N-95 meaning that the mask is adequate for filtering out 95% of PM_{2.5} particles. Masks should provide a tight seal around the wearer's mouth and nose. This may be particularly difficult for children. Paper or cloth "comfort" or "dust" masks offer little protection from fine particles.


The front page of the Air Quality Portal consists of the following main items:


b. Map of the monitoring stations

The map contains the monitoring stations marked with dots colored according to AQ Index levels. Offline stations are shown in gray.



On the left of the map there is a scrollable list of monitoring stations. Each list item contains a colored dot corresponding to AQ Index level, the station name and the name of the leading pollutant and its concentration.

When the user clicks on a list item, the map will be placed and zoomed in on the selected station and the station details will be displayed in a popup.



Above the station list, there is a text box for entering an address to search for places in Kosovo. After the user enters the address, a list of found locations is displayed below.



When the user clicks the selected location, the map will be placed and zoomed in on the location and will be displayed popup with the air quality data forecast.

3. Using the Advanced Map Tool

a. Overview


The Advanced Map Tool is a full-featured web mapping application and is used in the Air Quality Portal Kosovo to visualize the time-varying air quality data on the map.

The data on the map is displayed as layers. The map layers in are called "data sets" or simply "data".


In the Air Quality Portal multiple layers are entered, such as: monitoring stations, isolines for forecast parameters, concentration values for Kosovo regions.

b. Monitoring stations

View the full screen map using the menu item **Monitoring data** -> **Map of monitoring stations**. The map will display the *Air quality monitoring data* layer. The stations are displayed on the map as dots. The color of the dots is set according to Air Quality Index for the monitoring station at the selected time. Grey color means the station was down.



After clicking on a station - a pop-up window will appear with the details of the station.



The pop-up window contains:

- Station name
- Current time
- Air Quality Index as description and color
- Leading parameter
- Health recommendations for population groups
- Concentrations of measured pollutants
- Values of meteorological parameters.

c. Map layout and positioning

Advanced Map Tool page consists of three main parts:

- Workbench the left panel (can be hidden)
- Map
- Time slider at the bottom of the page.

In the upper left corner of the workbench there is the KHMI logo - when you click it, the front page will be displayed.

You can change the geographical area covered by map by dragging it or using the arrow keys.

The map can be zoomed in or out using the "+" and "-" buttons in the upper left corner. The middle between the "+" and "-" buttons resets the zoom and position of the map. Zooming can also be done with the mouse wheel.

The current time can be changed using the time slider:

- By dragging the slider
- By buttons: go to the beginning, play, slower, faster.

The current time can also be changed from the workbench in the *Time* section using the arrow buttons.

d. Map layers

Click the *Add Data* button on the workbench. A pop-up window with available layers will appear. You can use it to add layers to the map or remove them.

Add PM10 and O_3 layers by clicking "+".

Existing layers on the map are like a set of sheets on a table. You can see all layers, if their opacity is low enough.

If the first layer has 100% opacity you will only see the first layer. If you reduce the opacity - you will see other layers.

You can also change the order of the layers by dragging them in the workbench.

The last layer added is set first in the list.

e. Map splitting


To compare data on two different layers, but in the same time slider position, use a *Side-by-side comparison between two different sets of data*.

For example:

- 1. Click the Forecast data -> Forecast map for Kosovo -> PM10 menu item.
- 2. Click Add data and select O_3 and add to the map.
- 3. Click the *Enable side-by-side comparison* button:



- 4. Click *Left* on the PM10 layer in the workbench
- 5. Click *Right* on the O_3 layer.
- 6. By moving the split border, you can compare data for PM10 (on the left) and O₃ (on the right).



To compare data on the same layer but at different times - use the "Split" button on the selected layer in the workbench.

For example:


1. Click the Forecast data -> Forecast map for Kosovo -> PM2.5 menu item.

2. Click the *Split* button on the layer PM2.5 in the workbench – the map will be divided into two parts.

3. In the left part, change the time to the nighttime (from the workbench in the *Time* section using the arrow buttons).

4. In the right part, change the time to the daytime.


5. Move the split border and compare the data during the day and night.



f. Stories, sharing map and others

To create and share interactive stories directly from your map use the *Story* function:

- Click the Story button in the upper right corner of the map.
- Move the map to the desired location and time.
- Click the *Capture Scene* button. You will get a form to describe the captured scene.
- Enter a tittle and optional scene information and click Save.




Repeat the last three steps for the next slides.

After completing the steps for all slides, click the *Play Story* button - you can move from one slide to another by clicking the "<" and ">" buttons.

You can copy the slideshow using *Share / Print* function.


Click the *Share / Print* button, then the *Copy* button. The URL for accessing the slideshow is copied to the clipboard.

In the same way you can copy the URL of any map. You can paste the copied URL into a browser and view a map or slideshow.




You can center the map on your current location using the button under the zoom buttons.

If you allow the Portal access to your location, the map will be centered.



The Advanced Map Tool also allows you to measure distances between locations.

Click *Measure distance between locations* and click on the map to add points. The total distance will be displayed in the pop-up window.



4. Full screen maps

a. Overview

Full-screen maps are available using the main menu items. The full-screen maps include the monitoring stations map and the Kosovo and Pristina forecast maps.

The menu item **Monitoring data** -> **Map of monitoring stations** is used to display a map of monitoring stations.

The menu items for 3-day forecast maps are placed in two groups in the **Forecast data** menu item:

- Forecast data for Kosovo maps for AQ Index, pollutants, districts and municipalities in Kosovo
- Forecast data for Prishtina maps for AQ Index and pollutants in Prishtina.

After clicking the selected menu item, the corresponding map will be displayed in full screen.


All maps use for displaying data:

- for gases - hourly average concentration values,

- for PM10 and PM2.5 – 24-hour running averages.



This layer presents in full screen hourly data from air quality monitoring stations from the last 48 hours.




c. AQ Index – 3-day forecast data for Kosovo

The map displays hourly values for Air Quality Index – 3-day forecast and the last 24 hours.











e. PM2.5 - 3-day forecast data for Kosovo




f. NO₂ – 3-day forecast data for Kosovo
























5. Reports

a. Air quality from the last 24 hour/30 days/365 days for monitoring stations

The report is displayed on front page in the report section.

The report indicates the percentage of hourly measurement results from monitoring stations for individual AQ Index levels for these measurements over the last selected period.

For example, if a pie chart shows that 75% of the air quality is "fair", it means that 75% of hourly indices of all stations in the last selected period were in a "fair" state.


The report can be run for three groups of monitoring stations and for stations selected separately, and within each group, you can select a period (24 hours, 30 or 365 days).

In the panel on the left is displayed an appropriate list of the stations. When the user clicks on a station, a popup will be displayed with the details of the selected station.




Hourly concentration measurements from the stations are used for reporting calculations – for all substances.

Data are displayed for selected parameters and stations in a given time resolution and time range.








In the hourly time resolution, the user can select a time range (8, 24 or 48h) or a date range from the calendar.

In the monthly time resolution, the user can select a time range (3, 6 or 12 month) or a year range from the list. There is also a choice of data type (average, maximum).

In the annual time resolution, the user can select a year range from the list. There is also a choice of data type (average, maximum).



To apply the criteria, click the *Apply* button.

To display the data in tabular form, click the *Table* tab. The report data will be displayed in a paged table.


